MANAGER'S REPORT

Work on the Seawall has begun. We have 2 companies working together on this project. The first company is digging out the seawall by the seams and replacing dirt with clean fill. The second company is injecting polyurethane to seal the cracks. Also being added are weep holes with filters. This process will allow water to pass through the wall and hold the dirt and sand in place. This is the first phase of the project. More to come.

Reminder to all. Parking is at a premium. Please park in designated spaces only. Obey the speed limit as there are many bikers and walkers in the streets.

With the season coming up any owners that are considering renting their units must abide by the new rules. A copy of the rules and regulations was sent out to all. HARBOR LIGHTS COOPERATIVE, INC. BOARD OF DIRECTORS MEETING THURSDAY, December 8, 2016 9:00 AM IN THE CLUBHOUSE

- I. CALL TO ORDER: The meeting was called to order at 9:00 AM by President Sandwick.
- II. ROLL CALL: Bunnell, Dellina, Laughlin, Lewis, Pettengill, Sandwick, Wallace and Young. Wisdom present for management. Twenty-two shareholders present.
- III. CONFIRMATION AND POSTING: The meeting was duly posted and a quorum was present.

IV. READING OF MINUTES:

A. Board of Directors Meeting Minutes of 11-10-16 not read as all Directors had a copy and minutes were posted in the Beacon. Motion by Bunnell, seconded by Young to approve the minutes. Unanimous vote to accept.

V. MANAGER'S REPORT:

- A. SEAWALL UPDATE Progress is being made. Two companies are working on prepping and applying polyurethane. Work is progressing slowly (about 50 feet per day) and there are more and deeper holes than expected.
- B. FLAROC Chris Smith has volunteered to represent Harbor Lights and will attend the next meeting. Harbor Lights has been asked to host the March meeting. Chris will check with Jan Utley regarding available dates.
- C. SOUND BAR A new sound bar has been purchased and we will be seeking reimbursement from the Recreation Board at their next meeting. Tennis has requested a new roller for the tennis court and that request will also be taken to the Rec. Board.

VI. TREASURER'S REPORT:

Pettengill reported that fixed assets as of 11-30-16 are \$4,930,084.00 and total savings, checking and cash is \$1,027,906.13. Motion by Bunnell second by Dellina to accept the Treasurer's Report. Unanimous approval.

VII. ANNOUNCEMENTS: None.

VIII. UNFINISHED BUSINESS: None.

IX. NEW BUSINESS: An information meeting has been held regarding the proposed condos nextdoor. Preliminary plans call for four condos to be constructed over parking. The two end buildings would be five stories and the two middle buildings six stories. They would be shorter than the condos across the street. It was emphasized that the plans are very preliminary and have not received zoning approval as yet. Therefore, many changes are to be expected before a final plan is submitted and most likely it will be 1-1/2 to two years before anything is finalized.

X. SHAREHOLDERS COMMENTS:

- A. Bob Vilon introduced himself as owner of #100 and #54. He advised that the debris has been removed in front of #54. He is running for a position on the Board of Directors.
- B. In response to shareholders questions about the roads, we are still waiting for the company to prepare a test area and we are working on obtaining some form of reimbursement from the original contractor but first need to determine exactly what will be required to remedy the situation. The original preparation was not done properly.
- XI. ADJOURNMENT: Moved by Dellina, seconded by Wallace that the meeting be adjourned at 9:22 AM. Unanimous approval.
